Booklet with four pages in vertical format, with seam binding, paper stamped and re-stamped for enlargement time, in italic script to the right. The document is a consultation and certification of having paid what corresponds to Don José Antonio Barrón as accountant of the Court of Audits; it has the signatures of Viceroy Manuel Amat y Juniet, the Marquis of Salinas, Juan Francisco Navarro, Francisco Antonio de Arrieta and Joseph Antonio Gomero y Amat, in 1774. Drafted, in principle, on 30 April 1774; there are other records with later dates: of Juan Francisco Navarro and Francisco Antonio Arrieta, dated 4 May 1774, in Lima, or the record of Joseph Antonio Gomero y Amat, dated 5 May 1774. It shows regular state of conservation, with characteristics of belonging to a complex unit (book or file).

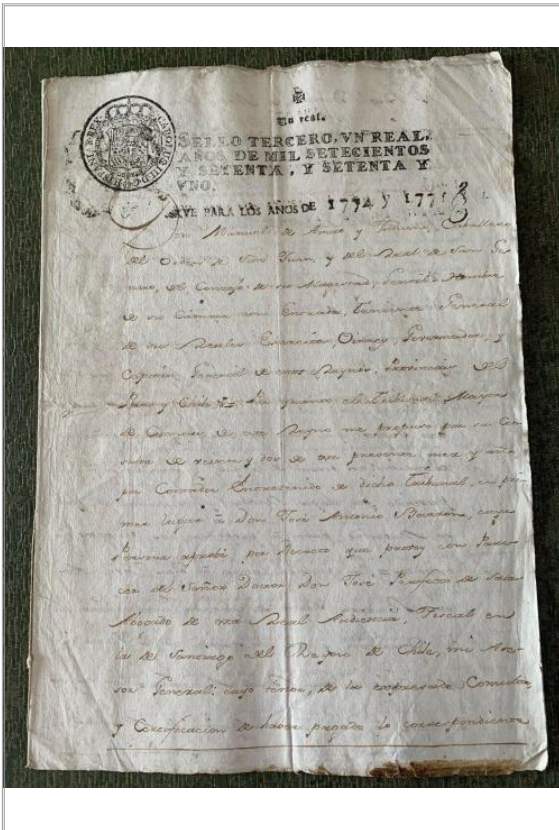


Image: Front view

Image: Front view, Upper detail

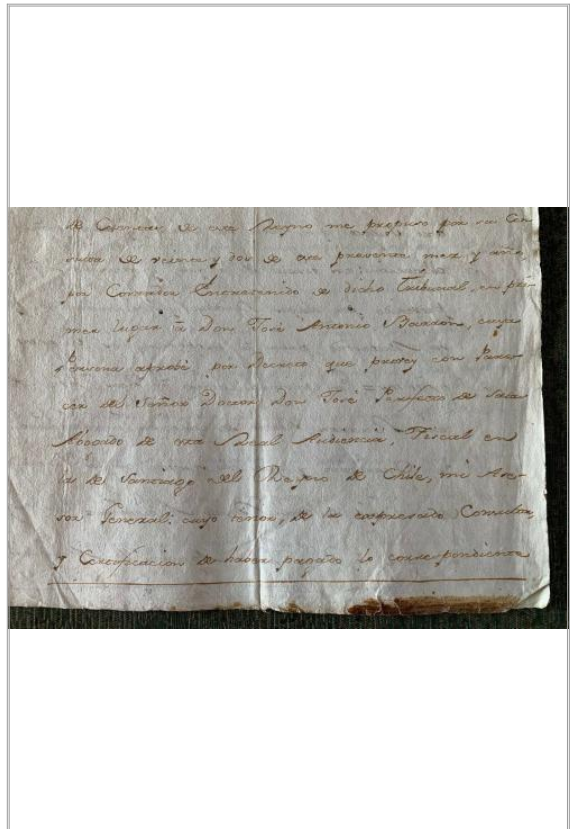


Image: Front view, Lower detail

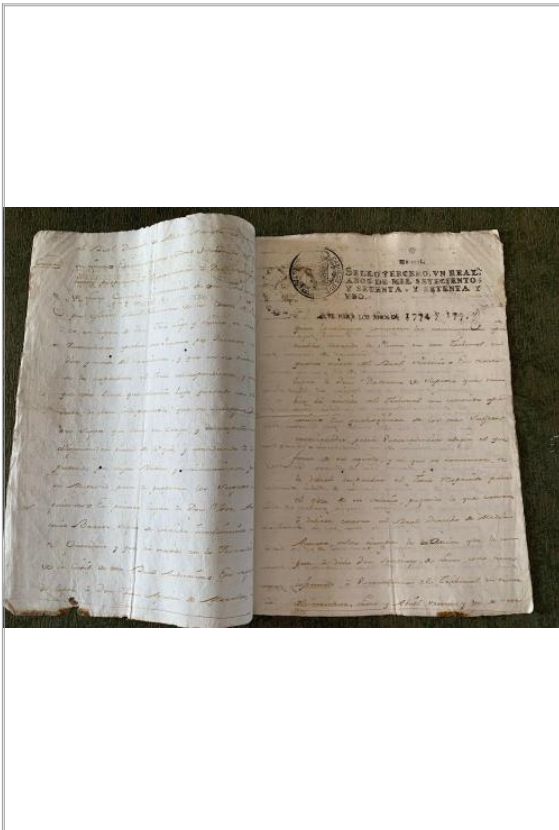


Image: Interior view

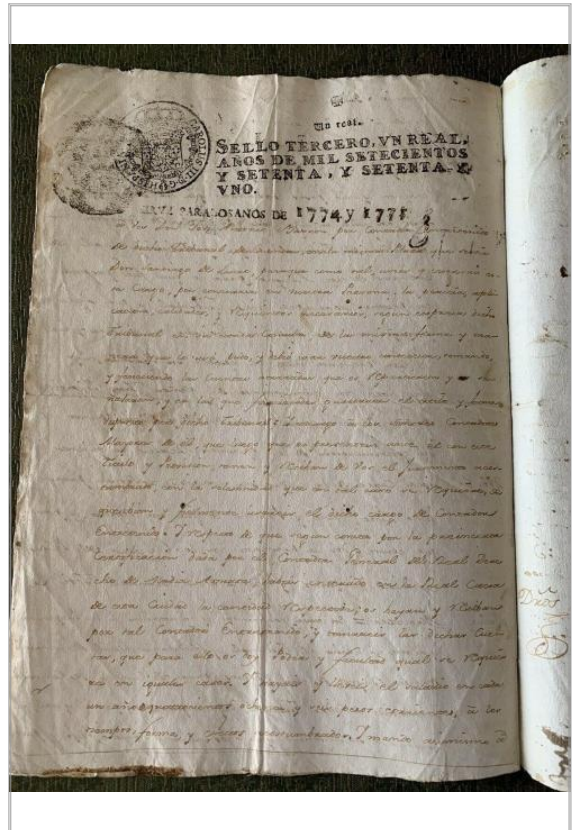


Image: Interior view, left side

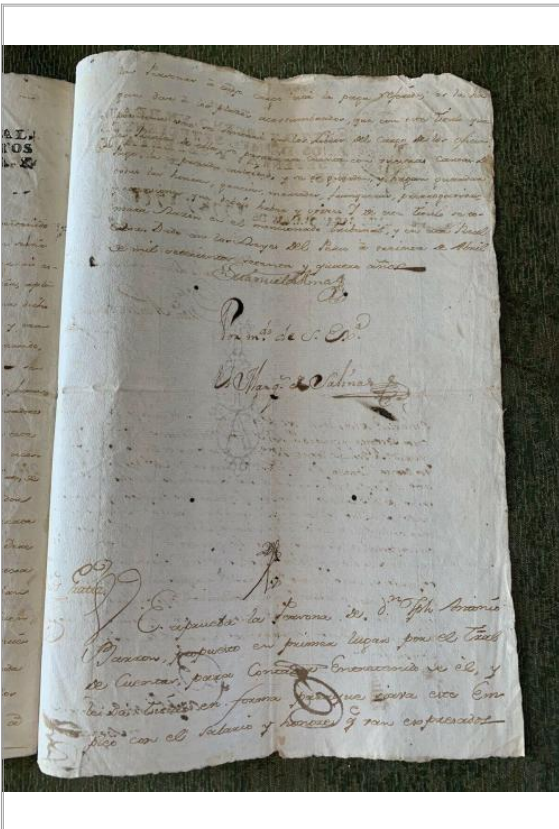


Image: Interior view, right side

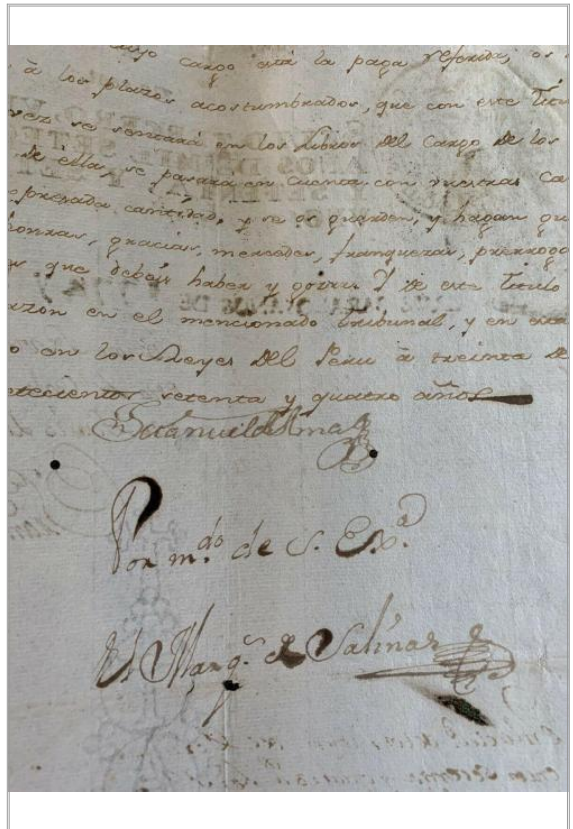


Image: Interior view, right side, detail

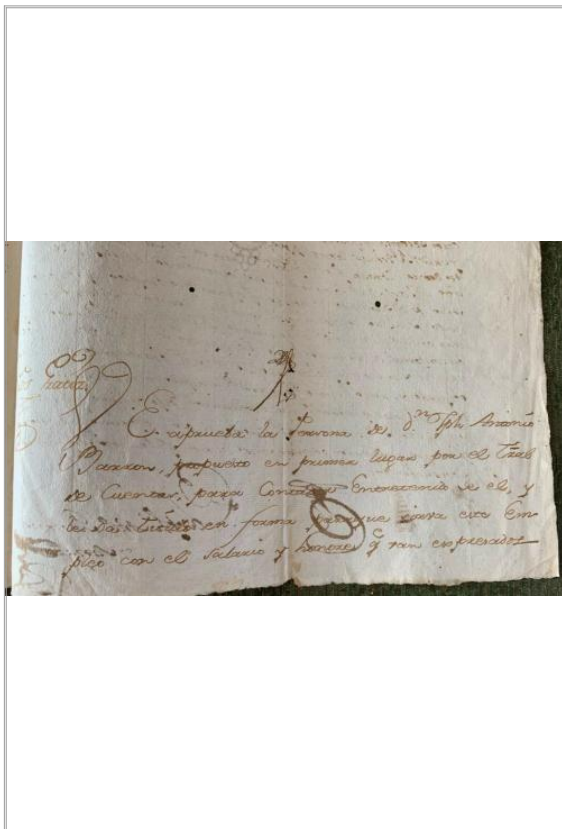


Image: Interior view, right side, detail



Image: Rear view, Upper detail

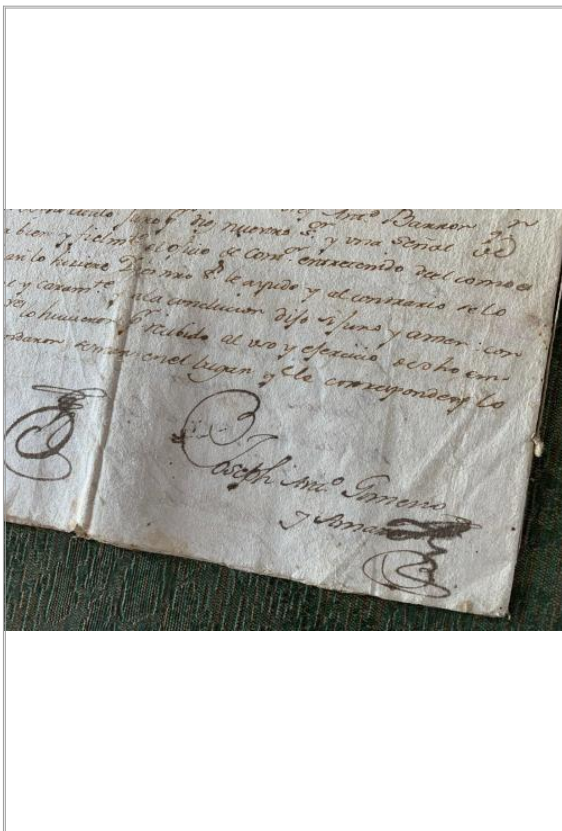


Image: Rear view, Lower detail
